

We believe that diversity and inclusion are essential to organizational success. We are committed to diversity and cultural competency in our programming, employment, and governance practices.

Identify information and service needs

Screened **2,393** participants and scheduled free income tax preparation with Alternatives Federal Credit Union Volunteer Income Tax Assistance/ Earned Income Tax Credit program (VITA/EIC). Hurricane Irene and tropical storm Lee resulted in road closures, leaky roofs and flooded basements. 2-1-1 kept in touch with county and state agencies & worked with individual households to connect them with weather-related information and assistance.

Provide planning and coordination

Attendance at the Homeless and Housing Task Force **increased by 35%** in 2011 as the group responded to issues ranging from how to assist the homeless population in the City of Ithaca to survey results from the Point-in-Time Count and Independent Living Survey. The Continuum of Care committee completed another successful HUD grant application and continues to work on the goals set forth in its recently completed Ten Year Plan.

Hosted presentations and participated in coalitions on emerging structures of care: patient-centered medical home, clinical integration, care transitions and Medicaid Redesgn.



Enhance the delivery of health and human services

Urgent Rx served 12% more people than in 2010. Issued 1,722 vouchers for 3,318 prescriptions worth about \$71,123. Offered information about health care subsidy programs.

The HSC Non-profit **Salary & Benefits Survey** was completed in 2011. The 57 participating organizations received electronic copies of the entire report, as well as Individual Reports that compared their responses with aggregate numbers from like-size organizations. The full report is available on the Coalition's web site, www.hsctc.org Seventeen human service agencies reviewed and represented by the Coalition received \$945,000 for 2012 through the County/City budget process. HSC's citizen Review Committee was instrumental throughout this process.
