Our Executive Director

We just finished our 40th year of doing business. HSC was established in response to the growth in human service programs that resulted from the funding of the War on Poverty. HSC's founders knew even then that a coordinated community approach was the smartest way to achieve long term results. Many smart, committed people have dedicated their energy and expertise to alleviating these conditions over the past 40 years. But, poverty remains, and as the world becomes increasingly complex, new demands add to the work of our nonprofit partners.

Milestones like this offer an excellent opportunity to step back and take a long look at both the successes we have achieved and the areas where we still struggle to find the right approach. The HSC staff and board of directors are just finishing up a two year strategic planning process that looks to the future and identifies HSC's continued role in providing leadership and support to our nonprofits. The plan emphasizes: 1) the need for data analysis that clearly identifies areas requiring a community response and that is available in a variety of concise, easily accessible formats; 2) the importance of leadership training and support to assure that our nonprofits continue to have strong management as well as a new generation of engaged board members; and 3) the necessity of continued outreach and coordination among agencies and key players so our community is prepared to respond to systems changes similar to what we are currently seeing in health care.

We are lucky that we do business in Tompkins County, where working together to achieve a common goal is the norm instead of the exception. In the coming years, there will be many changes to the systems we now know. HSC will be ready to provide the supportive resources upon which our community has depended for 40 years.

Forty Years of 745C...

The Health Planning Council met formally for the first time on June 20, 1968. The Council was formed in compliance with the federal Hill-Staggers Act requiring states, through each county, to formalize comprehensive health planning committees. In 1986 the federal health planning legislation expired and the Council negotiated an administrative relationship to continue their work as part of the Human Services Coalition.

Connecting People to Community Services

2014 saw some big changes in the 2-1-1 Tompkins/Cortland Call Center. The main focus was working on transitioning to an all new iCarol database platform. Our resource specialists and technicians worked hard formatting the over 2,200 programs in our database to transfer to iCarol, ensuring continued quality service to people in need of help.

The 2-1-1 Helpline continues to help people with needs such as housing assistance, free tax preparation appointments, ride requests for medical transportation, appointments for health insurance through the *New York State of Health Marketplace*, and much more. No requests are too big or too small. If you need help, you can reach a community services specialist by calling 2-1-1 or 1-877-211-8667.

- In 2014, the call center assisted 2,841 callers with income tax assistance, scheduling appointments for the *Alternatives Federal Credit Union's Volunteer Income Tax Assistance Program*.
- Call Specialists took 1,121 ride requests via 946 calls for the *FISH* volunteer medical transportation program.
 - Callers in 2014 identified over 3,400 health related needs to the 2-1-1 call center. Most were health insurance appointments, medical transportation, doctor/clinic information and medication disposal.

Diabetes and Other Chronic Diseases

The *Health Planning Council (HPC)* entered its third and final year of the Community and Member Health Initiatives grant from Excellus BlueCross BlueShield. The Cayuga Center for Healthy Living is the newest Diabetes Prevention *Program (DPP)* provider site joining the *YMCA*, *Tompkins* County Health Department, and HSC.



Healthcare Access

- HSC entered its second year as a navigator agency under the statewide network of the Community Service Society and expanded its capacity by adding 2 new staff. HSC Health Access Navigators assisted 659 individuals in Tompkins County in 2014.
- HSC applied for and secured funding from the Community Service Society to offer the Community Health Advocates program in Tompkins County.
- Urgent Rx issued 1.124 vouchers covering 1.926 prescriptions for medicine to people without healh insurance at the Cayuga Medical Center and Ithaca Free Clinic. Healthy Corner Store

Community Projects & Outreach

- 2014 was the fourth year of the five-year NYS Department of Health grant for Creating Healthy Places to Live, Work and Play (CHP). The CHP grant brings in \$239,704 annually to support projects in Tompkins County that increase physical activity opportunities and healthier eating. The grant also assists worksites in establishing wellness strategies.
- Accomplishments in 2014:
 - Transition of Streets Alive! to Way2Go and Bike Walk Tompkins
 - Through our partnership with Cornell Cooperative Extension, established the Floral Avenue Community Garden and launched the Healthy Corner Store Project at Pete's Grocery.



- Co-wrote the *Tompkins Priority Trails Strategy Paper* with the *Tompkins County Tourism Program*, which has been included in the *TC Comprehensive Plan*, 2020 Strategic Tourism Plan, and *ITCTC's 2035 Long Range Transportation Plan*
- Collaborated with active transportation professionals and advocates to form Bike Walk Tompkins
- Continued working with 13 local worksites.

HSC Workshop Series Attendees Through Time

2008: 349 attended 11 workshops

2010: 561 attended 36 workshops

2012: 695 attended 46 workshops

2014: 700 attended 42 workshops

- We added some free one hour lunchtime trainings, including *Energize Your Non-Profit Board*, and *Helping Clients Find Health Insurance*.
- This year for the first time we offered free on-site consultations to 21 area non-profit boards of directors to help them to carry out their work more effectively.
- In September we collaborated for the first time with *The Diversity Consortium of Tompkins County* (DCTC) to present *Understanding Emotional Intelligence* with Roxana Bahar Hewertson.
- We have three affinity groups that are up and running. *The Finance Officers Association of TC*, the *Chief Executives Association* and the 52 "Alumni" of the *Leading With Impact Senior Leadership Training Series*.
- We are about to launch our *Middle Managers Training Series* which will be new for 2015.

Funding to Local Agencies

- 17 agencies applied for support through the County/City review process. The County Legislature approved over \$1,000,000 in funding.
- The Social Services League made awards to 15 organizations. The awards ranged from \$500 to \$1,550 for a variety of projects including outreach, childcare, sign language, transportation, and equipment.

Continuum of Care

- David Scovronick, Executive Director of the Downtown Ithaca Children's Center, receives a funding check from Social Service League member The *Homeless and Housing Task Force*, the education arm of the Continuum of Care Committee (CoC), averaged 44 attendees at each meeting in 2014 with topics like So You Want to be a Fair Housing Advocate with Human Rights Commissioner, Karen Baer.
- Liz Warner started working part-time as the Continuum of Care Coordinator. This past year the CoC was awarded \$236,000 in funding to serve the homeless and those in danger of becoming homeless.
- The 2014 Point-in-Time Homeless Count of homeless in TC took in 97 surveys from the Tompkins County area. 56 of those surveyed fell into the categories of *Literally Homeless*, *Imminently Homeless*, or *Unstably Housed* (as categorized by *HUD*).

Other Resources for Non-profits

- HSC Forums averaged 36 attendees for its programs with topics which included Workforce Readiness and Employment Resources and information on the Nonprofit Revitalization Act.
- HSC updated its website making it easier to find resources such as the Meeting Space Directory, information on workshops, sign-up for the HSC Listserv, resources for nonprofit boards and staff, and access to the 2-1-1 database of services.
- The HSC Listserv currently has 3,005 members and continues to serve as a valuable communication tool for the community.


