3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Amici House Supportive Housing for Families Program targets young adults between 18-25 years old who are single, pregnant or parenting experiencing homelessness. All units are dedicated to chronically homeless families and individuals including individuals or families with an adult or child family member with a disability achieve housing stability. Our target population presents conditions related to substance dependence, mental and/or emotional impairments which impede the ability for them to stabilize that could be improved by our supportive services. To ensure that we serve the most vulnerable young adults we will participate in the CoC Coordinated Assessment process and screen applicants for eligibility using a low barrier, housing first approach. Our program philosophy is participant centered, we meet the participant where they are at and develop individualized goals that make sense for the participant. We believe that stabilizing housing is the most important first step in moving forward to build resiliency skills to avoid a return to homelessness. Amici House is sited adjacent to our main office location in Ithaca, NY. Amici House, consists of 23 enhanced studio apartments, each unit will have its own full bath and strip kitchen. The first floor connects to the TCAAction main office. Amici includes a large training space for residents, staff offices, laundry rooms, a playroom for very young children, a commercial training kitchen, an office for case-conferencing with our local collaborators. By offering supportive services to encourage educational and employment goals, each resident has a support network built into where they live. Access to quality early childhood services for parenting youth is essential to enable parents to participate in trainings/educational opportunities to prepare themselves for the job market, search and interview for appropriate jobs, and sustain employment once they have settled into a job. TCAAction’s Early Head Start Child Care Center is adjacent to the Amici House. The integration of Head Start and Early Head Start into the Amici House program creates opportunities for educationally based child care for women/children ages birth through 5, as well as, early childhood education, and supports for parenting and understanding and preparing for the developmental stages/changes of children. As an important component of all of TCAAction’s supportive housing programs, responsible tenancy habits are encouraged. Each resident is held accountable for timely rent payments and lease compliance, maintaining their home in a way that meets the Health and Safety Inspection, and for being a responsible neighbor. These housing sustainability skills are important while a resident is associated with our program as well as after when they transition out into the community.

This letter is in response to your request for a copy of your organization's determination letter. This letter will take the place of the copy you requested.

Our records indicate that a determination letter issued in June 1967, granted your organization exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. 

C. Leave and fringe benefits for above personnel only are included in the indirect cost pool.

D. Other Expenses - Administrative portion only: travel, telephone, postage, equipment rental, occupancy/utilities/maintenance, professional fees, contractual services, supplies, printing, copying, insurance, and misc. other.

(2) Treatment of Fringe Benefits: The directly claimed fringe benefits include FICA, Worker's Compensation, Unemployment Insurance, Disability Insurance, Health Insurance, Life Insurance and Retirement.

(3) Equipment means tangible personal property (including information technology systems) having a useful life of more than one year and a per-unit acquisition cost which equals or exceeds the lesser of the capitalization level established by the non-Federal entity for financial statement purposes, or \$1,000.

A. LIMITATIONS:

The rates in this Agreement are subject to any statutory or administrative limitations and apply to a given grant, contract or other agreement only to the extent that funds are available. Acceptance of the rates is subject to the following conditions: (1) Only costs incurred by the organization were included in its indirect cost pool as finally accepted; such costs are legal obligations of the organization and are allowable under the governing cost principles; (2) The same costs that have been treated as indirect costs are not claimed as direct costs; (3) Similar types of costs have been accorded consistent accounting treatment; and (4) The information provided by the organization which was used to establish the rates is not later found to be materially incomplete or inaccurate by the Federal Government. In such situations the rate(s) would be subject to renegotiation at the discretion of the Federal Government.

B. ACCOUNTING CHANGES:

This Agreement is based on the accounting system purported by the organization to be in effect during the Agreement period. The rates in this Agreement were approved in accordance with the authority in Title 2 of the Code of Federal Regulations, Part 200 (2 CFR 200), and should be applied to grants, contracts and other agreements covered by 2 CFR 200, subject to any limitations in A above. The organization may provide copies of the Agreement to other Federal Agencies to give them early notification of the Agreement.

E. OTHER:
