Supportive Housing for Families Program has two components: Amici House and The Corn Street Apartments providing permanent supportive housing to young adults between 18-25 years old who are single, pregnant, or parenting and experiencing homelessness. Amici House and Corn Street Apartments residents often present conditions related to substance dependence, mental and/or emotional impairments which impede the ability for them to stabilize that could be improved by our supportive services. Program activities include bringing community resources on site to our residents and offer presentations about community connections related to employment, education, and family development.

Our program philosophy is resident centered, we meet the residents where they are at and develop individualized goals that make sense for the resident. Staff work with the residents to break down the large goals into manageable action steps. We believe that stabilizing housing is the most important first step in moving forward to build resiliency skills to avoid a return to homelessness. By offering supportive services to encourage educational and employment goals, each resident has a support network built into where they live. Access to quality early childhood services for parenting youth is essential to enable parents to participate in trainings/educational opportunities to prepare themselves for the job market, search, and interview for appropriate jobs, and sustain employment once they have settled into a job. TCAction's Head Start/Early Head Start Child Care Center is adjacent to the Amici House and transportation is provided to the families at Corn Street to assist with getting the children to program daily. As an important component of all of TCAction's supportive housing programs, responsible tenancy habits are encouraged. Each resident is held accountable for timely rent payments and lease compliance, maintaining their home in a way that meets weekly Health and Safety Inspection, and for being a responsible neighbor. These housing sustainability skills are important while a resident is associated with our program as well as after they transition out into the community.

This letter is in response to your request for a copy of your organization's determination letter. This letter will take the place of the copy you requested.

- C. Leave and fringe benefits for above personnel only are included in the indirect cost pool.
- D. Other Expenses Administrative portion only: training, travel, telephone, postage, equipment rental, occupancy/utilities/maintenance, professional fees, contractual services, supplies, postage, vehicle, information technology, insurance and miscellaneous.
- (2) Treatment of Fringe Benefits: The directly claimed fringe benefits include FICA, Worker's Compensation, Unemployment Insurance, Disability Insurance, Health Insurance, Life Insurance and Retirement.
- (3) The indirect cost rate has been negotiated in compliance with the Administration for Children and Families Program Instruction (ACF-PI-HS-08-03) dated 5/12/2008, which precludes recipients of Head Start grants to use any Federal funds to pay for any part of the compensation of an individual either as a direct cost or any pro-ration as an indirect cost if that individual's compensation exceeds the rate payable of an Executive Level II. As of January 2021, the rate of compensation for an Executive Level II is \$199,300 per year. As of January 2022, the rate of compensation for an Executive Level II is \$203,700 per year.
