## 3B. Project Description

### 1. Provide a description that addresses the entire scope of the proposed project.

Magnolia House provides permanent housing to families experiencing homelessness, with a parent who is active in recovery from substance use dependence. There are 14 studio apartments that include furnished sleeping/living space, a kitchenette and a full bath. Each studio can accommodate an adult and up to two children based on square footage. There is a commercial training kitchen, a training classroom, a children's play room, two lounges, and fenced in outdoor space. The building includes staff offices and space designated for community partners' use.

Each resident meets with staff to review the Lease and Program Agreement expectations of responsible tenancy and program participation at move in and at least annually. All programming incorporates short and long term goals involving housing stabilization and family engagement in an environment that focuses on building life skills and parent engagement. Along with committing to educational and financial goals, each resident demonstrates an understanding of and commitment to the resident responsibilities outlined in the lease agreement. Staff complete apartment inspections monthly with each family, focusing on general health and safety items. This inspection is used to reinforce practices of responsible tenancy; maintaining cleanliness and safe family environments. In addition to weekly resident home visits each resident has with staff, there are also monthly social gatherings and on-site trainings. Each resident is connected to a team of support; staff are trained to provide strength based family development services and facilitate referrals to other community supports. Staff create strength based family partnerships with each resident that support developing and fostering healthy self-concepts, recognition of families as primary teachers as well as responsible guardians of their child's wellbeing.

Staff support residents to complete their education; gain job skills needed to improve employability and increase job retention; develop financial literacy, and maintain positive relationships within the family and the community; including intensive one to one support and group activities to overcome barriers to achieving self-sufficiency and achieving good tenancy. This letter is in response to your request for a copy of your organization's determination letter. This letter will take the place of the copy you requested.

Our records indicate that a determination letter issued in June 1967 granted your organization exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in section 509(a)(1) and 170(b)(1)(A)(vi).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. 

TREATMENT OF FRINGE BENEFITS:

TREATMENT OF PAID ABSENCES

C. Leave and fringe benefits for above personnel only are included in the indirect cost pool.

D. Other Expenses - Administrative portion only: travel, telephone, postage, equipment rental, occupancy/utilities/maintenance, professional fees, contractual services, supplies, printing, copying, insurance and miscellaneous.

(2) Treatment of Fringe Benefits: The directly claimed fringe benefits include FICA, Worker's Compensation, Unemployment Insurance, Disability Insurance, Health Insurance, Life Insurance and Retirement.

(3) Equipment means tangible personal property (including information technology systems) having a useful life of more than one year and a per-unit acquisition cost which equals or exceeds the lesser of the capitalization level established by the non-Federal entity for financial statement purposes, or \$1,000.

**SECTION III: GENERAL**

**A. LIMITATIONS:**

The rates in this Agreement are subject to any statutory or administrative limitations and apply to a given grant, contract or other agreement only to the extent that funds are available. Acceptance of the rates is subject to the following conditions: (1) Only costs incurred by the organization were included in its indirect cost pool as finally accepted; such costs are legal obligations of the organization and are allowable under the governing cost principles; (2) The same costs that have been treated as indirect costs are not claimed as direct costs; (3) Similar types of costs have been accorded consistent accounting treatment; and (4) The information provided by the organization which was used to establish the rates is not later found to be materially incomplete or inaccurate by the Federal Government. In such situations the rate(s) would be subject to renegotiation at the discretion of the Federal Government.

**B. ACCOUNTING CHANGES:**

This Agreement is based on the accounting system purported by the organization to be in effect during the Agreement period. Changes to the method of accounting for costs which affect the amount of reimbursement resulting from the use of this Agreement require prior approval of the authorized representative of the cognizant agency. Such changes include, but are not limited to, changes in the charging of a particular type of cost from indirect to direct. Failure to obtain approval may result in cost disallowances.

**C. FIXED RATES:**

If a fixed rate is in this Agreement, it is based on an estimate of the costs for the period covered by the rate. When the actual costs for this period are determined, an adjustment will be made to a rate of a future year(s) to compensate for the difference between the costs used to establish the fixed rate and actual costs.

**D. USE BY OTHER FEDERAL AGENCIES:**

The rates in this Agreement were approved in accordance with the authority in Title 2 of the Code of Federal Regulations, Part 200 (2 CFR 200), and should be applied to grants, contracts and other agreements covered by 2 CFR 200, subject to any limitations in A above. The organization may provide copies of the Agreement to other Federal Agencies to give them early notification of the Agreement.

**E. OTHER:**

If any Federal contract, grant or other agreement is reimbursing indirect costs by a means other than the approved rate(s) in this Agreement, the organization should (1) credit such costs to the affected programs, and (2) apply the approved rate(s) to the appropriate base to identify the proper amount of indirect costs allocable to these programs.
