Lakeview's SRO in Tompkins County provides permanent supportive housing for chronically homeless, disabled individuals who have been unsuccessful in other living arrangements. Each individual has a single room with private bathroom, kitchenette and a full meal plan. On the first floor there is an activities room and large communal dining room. Each floor also has laundry facilities and community lounges where people gather to socialize. Staff provide a range of services from medication management to daily living skills. Staff provide various recovery and wellness-focused groups based on residentidentified interests. Each individual drives the creation of a service plan based on his/her life goals. Resident meetings are held on a bi-weekly basis to foster accountability and leadership within the building and annual program goals are identified and evaluated through annual satisfaction surveys. A Peer Support Specialist is an integral member of the staffing team and offers advocacy, guidance and support using his/her own shared experiences to program residents. Although the program makes every effort to use a housing first approach, requirements of Low Income Housing Tax Credit programs, which the SRO was funded through, can often create barriers/challenges in truly implementing a housing first model.
