Meeting critical mission objectives over time have resulted in an accomplished history of successful and responsible administration of public and private grant and contract funding awarded to SJCS across five (5) states. Among the organization's most enduring partnerships are long-standing relationships with Departments of Human Services, Departments of Disability Services, CoC's, Rehabilitation Services Administrations, and Healthcare Finance Administrations (Medicaid). In addition to the above, SJCS has the following contracted services.

On November 1, 2018, SJCS was awarded a Tompkins County contract to operate the Ithaca, New York Shelter and Day Center. The program includes adult and family shelter; day center; food pantry; low barrier, permanent housing; and, outreach/linkage services.

Using a Housing First approach built on the principles and methods of trauma informed care, St. John's Community Services-NY (SJCS-NY) proposes to support 5 chronically homeless individuals with children, through scattered site PSH+. It is anticipated that five of the housing units will be two – bedroom apartments and five of the units will be three bedroom apartments throughout Ithaca and Tompkins County. While first and foremost the objective is to secure safe and affordable housing, which they will help select, SJCS-NY will employ its extensive history and experience with individualized, clinical, employment, educational, and person-centered services to support these individuals to define and move toward life goals with respect to mental and physical health, relationships, employment, education, parenting skills, chemical abuse, and other life domains. These services will be designed to develop a personal vision of their better tomorrow and support that vision toward greater interdependence, self-sufficiency, personal development, and permanent housing. All of this will be done by meeting each family member where they are at, building on their strengths, addressing their support needs, and moving at the pace "where they are at". This means that SJCS will remain committed to securing and assisting those we serve in maintaining housing as essential and non-negotiable, with no programmatic prerequisites, and regardless of gender conformity, sobriety status, or other restrictive admission policies. Core values that have guided SJCS program development and services are that all people should be able to live fully and completely in a community and environment of their own choosing, and, have access to the services and supports needed to establish and maintain their economic, physical, and social inter-dependence. Services will include intensive case management focused on meeting families where they are at, rapidly securing housing and other benefits for which they qualify. All services include Motivational interviewing, Trauma informed care and a housing first approach that places no artificial requirements or consequences on those we serve but will work to build strong relationships and help the family develop a personal vision for their "better future". After placement, the case manager will provide regular support, linkage, warmhandoffs and education and support toward a permanent move out of homelessness, and better self-manage of life challenges. As crisis and challenges always seem to happen, or become overwhelming outside of regular business hours, SJCS will offer 24/7 access to our remote support center. This is staffed by trained SJCS staff and can provide guidance, support and assistance to individuals served on their time, or as they are in need, along with access to Station MD.

SJCS currently works closely with DSS, TCMH, The Ithaca Free Clinical, Cayuga Medical Center and other mainstream, health, social service and employment programs. SJCS will leverage these relationships and provide linkage and warm handoffs to assure benefit attainment and appropriate care.
